The Active Dredge Area defines the area available to be dredged at any one time. While under normal circumstances this is defined by the limits of the licence, zoning schemes (introduced either as licence conditions or as voluntary initiatives by licensees) can significantly reduce this area. The limits of the Active Dredge Areas defined on this chart are monitored through the analysis of Electronic Monitoring System data.

Any changes to Active Dredge Areas presented on this chart after 31/01/2007 are the responsibility of individual licensees, as bound by specific licence conditions or agreed arrangements.
