Request response

Thank you for your correspondence regarding the 'Dragon's Teeth' at Minsmere. In your letter you requested some recorded information, and as The Crown Estate falls under the scope of the Freedom of Information Act, our reply has been made in accordance with the Act.

You asked for:

- a map to illustrate the area that The Crown Estate owns and the position of the boundaries with the adjoining landowners;

- copies of relevant correspondence between The Crown Estate and the adjoining landowners about the issue of the 'dragon's teeth'.

I have attached a map (Attachment 1) showing the limits of our ownership and the approximate position of the 'Dragon's Teeth'. It appears that we don't own the foreshore where they are situated, but we do own the seabed below mean low water.

I have also attached our correspondence in this matter (Attachment 2) which was dealt with by our managing agent on our behalf.

Also attached is a file (Attachment 3) showing the signage used in the area and some photographs of the site which I hope you find useful.

You also asked whether The Crown Estate and the owners of the foreshore at this location agree to expedite information signs at the relevant access.

The Crown Estate has been working with the neighbouring landowners regarding the erection of information signs at relevant access points to the beach. The Crown Estate has provided the RSPB with two signs which they have agreed to erect at the end of North Wall and at the sluice, where visitors to Minsmere Reserve can gain access to the beach. We have also provided the National Trust with new signs which they will be erecting at the end of the footpath leading to the beach from the Coastguard cottages at Dunwich.

I hope that this information is helpful. However, if you are not satisfied with the response to your Freedom of Information request, you may complain or appeal our decision, which will be investigated through an Internal Review. If you are not content with the outcome of the Internal Review, you have the right to refer your complaint directly to the Information Commissioner's Office (ICO) for a decision (contact details are available at: www.ico.org.uk). Please note that the ICO will usually expect you to have first exhausted our own complaints procedure before raising your concerns with them.

Hi Alison – thanks for your email. I took the chance with a flying visit yesterday as I hadn't had a reply from Claire. Sorry to have arrived unannounced.

RSPB have agreed to erect two signs at points of egress from their land in the vicinity of the dragon's teeth; one at the end of North Wall and one by the EA sluice. Any other access point would certainly be too remote.

The signs are not branded as the majority of the dragon's teeth are not on Crown land. The intertidal beach is owned by the Thorpeness estate. However we cannot expect the public to discern the line of mean low water which defines the ownership. Similarly, I don't imagine visitors gaining access from your land will consider whose land they are on if they come across these hazards. I wouldn't have thought a sign on your land would amount to ownership, anymore than it does with RSPB. It is merely a case of providing a message to beach users, who are gaining access from your land.

We have investigated the consents required to remove the dragon's teeth or to provide markers in a closer position. (We are dealing with a similar problem at Kessingland.) A Marine Licence will be

required and an HRA must accompany the application. This will take a while so we considered temporary signs would be helpful until we can (with others) determine the best strategy. Placing these at the three most widely used access points in the immediate vicinity is the idea.

I'm pleased we are communicating on this matter which has attracted a lot of recent attention. For what it's worth, when I was fixing the sign, it was welcomed by a lady coming down the path who spoke to me.

My concern is that these warning signs are so far away from where the actual risk is and you have not placed signs along the other access points so the message may get missed? Also that our visitors think the hazards are on our land when they have been removed many years ago.

I have taken the sign down and would ask you to think about where these are located and to brand up the message so our visitors are not confused. I think these would be better placed within the locality of the dragons teeth on stakes in the ground rather than just at entrance points. I know the RSPB own that land but I'm sure they will not object to the signs being placed prior to the work being done.

Thanks for your helpful response. I've attached some images and wonder if you could mark the position of your North Wall exit and return one of them to me.

We do not think it is appropriate for any party's contact details to be present on the signage, not least because there are multiple parties potentially involved – The Crown Estate for the seabed, the Thorpeness Estate for the foreshore and the RSPB and National Trust whose land affords some of the public access onto the beach.

Like you, we've been aware of the dragon's teeth on the foreshore but only recently aware of the tank traps on the seabed. There have been a number of recent reports and press interest, possibly due to a loss of beach material making everything more visible.

Dear John – I refer to our conversation on Friday.

I explained, there is a similar problem at Kessingland. In that position TCE own both the foreshore and the seabed. We are currently working on a plan to remove some of the items, make others safe and mark what remains. I promised to update you when we have some progress to see what we can learn and apply to Minsmere.

I spoke yesterday to RHDHV Haskoning who are project managing for TCE. A Marine Licence will be required for the work. It doesn't qualify for 'fast-track' so could take 13 weeks to determine. An HRA will be required, which in turn is dependent on a detailed site survey. Our next step is to commission the survey. Because of the many environmental designations at Kessingland, the intention is to work from boats wherever possible. With the difficulties of access, I expect the same might be true at Minsmere even if it is only to deliver equipment and remove the debris.

Given the joint ownership and debris on both our clients' land, are you thinking about working together at shared cost? I know TCE would be happy to proceed on this basis. If your client is of a similar view we should think about putting something in writing.

Many thanks for your email.

I agree with your statement "the information to hand doesn't indicate that the foreshore on which the dragon's teeth are situated is not owned by your client" but should add that neither does it indicate that the foreshore on which the dragon's teeth are situated is owned by my client.

The claim conceded in 1925 is based on "the foreshore below high water adjacent to the Manor of Leiston, Suffolk, within the limits shown on the map..." and so I agree that it is very frustrating there is no map included in the file.

Based on the information provided, I am not certain one can conclude that the 1925 claim related to the foreshore adjacent to all of that Manor (which you advise encompassed the Parishes of Leistoncum-Sizewell and Aldringham-cum-Thorpe), only that element of the foreshore shown within the limits on the missing map. Can I please ask whether you can provide an extract from the map to the south of the one you have provided, below? My thinking being that if the green area shown on the extract you have already provided, extends southward to include part or all of the area covered by Title SK160398, attached, it would imply that not all of the foreshore adjacent to the Manor of Leiston was conceded to Ogilvie in 1925 because the property included within Title SK160398 appears to have been transferred from The Crown to EDF in 1996.

I look forward to hearing back from you in due course.



The file on the Ogilvie claim has finally arrived (attached). Rather annoyingly, there are no plans in it. The claim conceded in 1925 was based on, "the foreshore below high water adjacent to the Manor of Leiston, Suffolk". The Manor encompassed, apparently, the Parishes of Leiston-cum-Sizewell and Aldringham-cum-Thorpe.

The final note in the file indicates The Crown Estate record maps being noted in 1961. The 1961 record maps were the County Series. I have made a requisition for the Suffolk edition. These maps were superseded by this map which shows the northern limit of the claim as below:



I've marked the northern extent of the dragon's teeth in red. As you can see this is within the area The Crown Estate notes as being admitted to your client.

When I received the County Series map we can undertake a similar exercise and also attempt to locate it by reference to the parishes referred to above. I'll be in touch, but at this moment the information to hand doesn't indicate that the foreshore on which the dragon's teeth are situated is not owned by your client.

Dear Mr Riches

I have been asked to contact you on behalf of my clients, Mr G S Ogilvie and the Ogilvie Family Trust. I understand that you have made contact with Glen regarding tank traps and dragon's teeth along Sizewell Beach.

You believe that the tank traps are on Crown Estate property, being located below the low water mark, but have enquired as to whether the dragon's teeth are on property owned by Mr Ogilvie, being between the high and low water marks.

Attached is the plan which you have provided to show the location of the invasion defences. Also attached is an extract from the Land Registry's Map Search system. The point shown on your plan as "North end of debris field 23.02.19" appears to be unregistered, the land to the west being registered to the RSPB. Whilst I cannot therefore confirm who owns the land at that location, it is certainly not property that Mr Ogilvie or the Ogilvie Family Trust believe forms part of the Sizewell Estate.

Whilst the Sizewell Estate does include some of the coastline in this locality, including to the low water mark at some points, the northern extent of this ownership is approximately 4.8km to the south of the "North end of the debris field 23.02.19" and so, I assume, was not included in your survey.

I trust this is all clear and helpful but please do not hesitate to contact me should you have any queries or requests.


